

- COMPETITION RULES -

THE IIM LAUNCHES THE CONTEST: MY MACAU, MY LOVE WHICH IS GOVERNED BY THE PRESENT REGULATION, IN THE PLEAD TO PRESERVE MACAU'S UNIQUENESS, TO ENHANCE THE SENSE OF BELONGING AMONGST THE CITIZENS, PARTICULARLY IN THE YOUNGER GENERATION, AND TO PROMOTE THE IDENTITY CONCEPT BASED ON CULTURAL AND HISTORICAL VALUES OF MACAU.

ART. 1 This contest has the objective to foster the knowledge amongst citizens, especially of the young people, about the heritage assets of Macau and the traditions that shaped Macau's culture.

ART. 2 This contest must portray views of the city that the author would most appreciate, such as buildings, events, practices, customs, beliefs, gastronomy, etc. and whom he/she is culturally identified with.

ART. 3 The contest is launched by the International Institute of Macau (IIM) in collaboration with the Macao Digital Photography Association (AFDM) and the Macau Central Leo Club, with the support of the Macau Foundation, and is divided in two sections:

☞ **Students section:** for local students who attend primary or secondary schools or any university in Macau;

☞ **Open section:** only for holders of Macau's Identification Card for Residents.

ART. 4 *Requirements related to entries*

- ✓ The entries submitted, without any limitation in quantity, must be original creations, never published nor awarded before.
- ✓ Digital editing conducting to their alteration is not allowed.
- ✓ The works should be submitted in digital JPEG format, having a resolution of not less than 4 megapixels.
- ✓ The contestants must give a title to their works. The name of the photos' digital file must be comprised by the romanized name of the contestant according to his/her ID and the entries' titles.
- ✓ The application form, duly filled, should be submitted altogether with the CD or USB, where the entries are stored, a photocopy of the ID/BIR (and the Student Card, in case of entries to the Students Section), in a closed envelope, having written on the outside: **ENTRIES FOR THE PHOTOGRAPHY CONTEST OF IIM**, and delivered to one of the addresses listed below, not later than **August 31, 2017:**

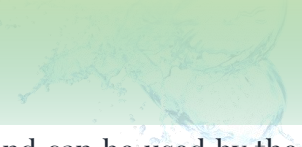

ART. 5 The entries submitted to the contest will not be returned and can be used by the International Institute of Macau for its publications.

The participants, by submitting their photos to contest, are expressly authorizing IIM to show their works, as well as to eventually for publicity and reproduction in printed material, publications, exhibitions, posters, on the internet and other graphic media produced by IIM, and assuming responsibility for the copyrights to the image and the reputation regarding the content of the entries submitted.

ART. 6 The jury will be comprised of **five** members, to be appointed by the organizers, being professionals in the area.

ART. 7 The criteria for assessment by the members of the jury appointed for this contest should be in accordance to those listed in this regulation.

Entries will be classified, in each section, for the 1st to 3rd place.

Honour awards can be given, if the members of jury deem so.

ART. 8 In each section there will be a 1st, 2nd and 3rd prize winner and honour awards (up to 10) receiving:

- ✓ 1st Prize – Certificate, trophy and a cash prize of MOP 5.000;
- ✓ 2nd Prize – Certificate, trophy and a cash prize of MOP 3.000;
- ✓ 3rd Prize – Certificate, trophy and a cash prize of MOP 2.000;
- ✓ Honour awards – Certificate, medal and a cash prize of MOP 500.
- ✓ Special prize for the best entry submitted by member of AFDM: will receive a cash prize of MOP 1.000.

Certificates will be presented to all participants.

ART. 9 Disclosure of the results of the contest and the presentation of prizes will take place in the last quarter of the current year, and contact will be done only with those awarded contestants.

An exhibition organized by IIM shall be made with a selection of the works of the competition.

ART. 10 Missing any information or non-compliance of any item of the above regulation might exclude the contestant and the entries from the contest, being final the decision of the jury.
